## Property Owner Information

### Cleaning

Little Pink wants to make sure the standards you have set for your home are maintained as a part of participation in our Breast Cancer Retreat Program. There are several options for cleaning, and we desire to honor whichever choice you make. You can select the option that best suits you on the online form.

1. Maintain your current cleaning contract and provide Little Pink Houses of Hope with an invoice for the cleaning service. We will pay the cleaning service/ cleaner designated within 15 days of receipt of the retreat completion date. Little Pink will make payment to the designated invoice address.
2. If you use a property management company and your cleaning service is part of a larger fee, Little Pink will pay the appropriate fee to the management company. Please provide us with this information.
3. Little Pink has donated cleaning services available in most locations. If you choose, we will enlist those services at no cost to either the owner or Little Pink.
4. You or the property management company can choose to donate the cleaning services.

### Linen Service

Please advise Little Pink regarding the linen usage for your property. You may donate the use or cost of using the linens with cleaning, or we can supply the linens as needed.

### Insurance

Little Pink Houses of Hope has complete insurance coverage through HUB International for all property liability and indemnity for up to 10 million dollars on each unit/home used in our program. Any insurance claims for property should be immediately communicated to our Retreat Manager, Kim Oakes, within 24 hours of departure and prior to additional tenant use.
